## THE PRESIDENT'S LETTER

Dear Members:

I am real pleased with how your Society is getting started in 1969. We have more members than we have ever had this early in the year. We have wonderful cooperation from the local members in assisting Jewel with the publications.

We now have in stock 1963 "Ansearchin'" and hope to have 1962 back from the publishers in the very near future. This will allow us to furnish all back issues to anyone desiring them.

We had for our speaker at our April night meeting Mrs. Gerald (Bobby) McClane of Hot Springs, Arkansas. Bobby gave us much information about the records available in Arkansas and what their Association was doing toward furnishing additional material for those interested in Arkansas records. She mentioned in her presentation the records available from questionnaires sent out to Civil War Veterans. Possibly many of you know of these records, but I had never heard before that they were available.

Georgia (Mrs. W.L.) has ancestors that were in Arkansas. When we returned from Texas recently where we had visited our son and his family, we stopped in Little Rock and checked the questionnaires sent out by the Arkansas Historical Commission to those Civil War Veterans attending the 1911 Convention. She found that her grandfather, Alexander Stuckey, had attended the convention and completed the questionnaire. For the first time she found who his Mother was, as well as the exact name of all the children.

I have checked concerning Tennessee and find that the Manuscript Section of the Archives Division of the Tennessee Archives and Library, Nashville, has an index to the questionnaires sent to Civil War Veterans in Tennessee. These questionnaires were sent in 1914 and 1915 and again in 1920 to all living Veterans. The index indicates the 1466 Confederate Veterans and 115 Federal Veterans who replied and brief information concerning them. This index is free upon request and should be a wonderful source of material to those interested in Tennessee ancestors. The questionnaire covers the ancestry of the Veteran and gives much good information in assisting in ancestor hunting.


We have obtained Virginia Pope (Mrs. Leon J.) Livingston, Chester, Virginia as the second member of our seminar team who joins Mr. John I. Coddington, Bordentown, New Jersey. Both of these speakers are highly recommended to us and we are looking forward to hearing from them on August 28, 29 and 30.

I would like to encourage members who are in Shelby County or nearby to attend our night meetings since we are having very good programs and would like to have your attendance and suggestions of how we can improve.

Our Editor and her staff are working hard on the Sesquicentennial of Shelby County issue and I am looking forward to this issue with great anticipation.

Again I solicit your suggestions of any way you feel we can improve your Society or our publication "Ansearchin'" News.

Yenawine's Checklist appears in the Georgia Archives Publication #5, Oct. 1967; A 1790 census of Elbert County Georgia from Wilkes County Tax Digests superimposed upon a 1967 county outline map consisting of 11 Militia Districts made into Elbert County from Wilkes County, Ga. by an Act of the Legislature 10 Dec. 1790 with an arrangement of District Companies and militia men of Colonel Cunningham's Battalion of Wilkes County has been compiled by Mr. Frank Parker Hudson and sells for \$1.50. Order from Georgia Genealogical Society, Inc.; The Indian issue, 1968, Ruth Corry, Editor, called "Frontier" carries articles by Mr. James M. Puckett, Jr. who has been a steady contributor as on "The Wofford Settlement" and "Meigs Line." These volumes contain many lists of white men with Indian families; lists of persons who have taken the Prescribed Oath and are permitted to continue their residence in that part of the state occupied by the Cherokees; an 1833 Creek Indian census, an 1835 Cherokee census and a list of Murray County Rangers, Georgia Guard, 1838.

An advertisement in The Commercial Appeal, Memphis, Tenn. on March 2, 1969 states that "In anticipation of South Carolina's 300th anniversary celebration in 1970, the Tricentennial Commission is currently gathering as much material as possible on significant family and group migrations in the 1800s. ## BOOK REVIEWS

MARRIAGE RECORDS OF COPIAH COUNTY, MISS. 1823-1843.  
MARRIAGE RECORDS OF MADISON COUNTY, MISS. Bk. "E" 1830-1836.  
MARRIAGE RECORDS OF MARION COUNTY, MISS. 1812-1860.

Each of the above books has a brief history of the county in the foreword and an average of about 60 pages of mimeographed source material completely indexed. These books are neatly done and easily read and should be very valuable for those researching in Mississippi. They are modestly priced at \$5.00 each. Order from Mrs. R.C. Upton, Madison, Mississippi 39110.

BRITISH FAMILY NAMES: THEIR ORIGIN AND MEANING (By Rev. Henry Barber. Order from Gale Research Company, Book Tower, Detroit, Michigan 48226. Price: \$12.75.)

This book has 386 pages containing hundreds of names with concise information on each. The British Surnames are in eight categories such as nicknames, clan or tribal names, foreign names, foundling names, official names, trade names, place names and Christian names. Also included are lists of Ancient Appellations such as Old Norse personal names, Frisian personal and family names, names of persons entered in the Domesday Book and Names of tenants in chief and under-tenants of lands at the time of the Domesday Survey. There is a chapter on Norman names. This is a book of particular interest to the advanced genealogist. It is a reprint from the original printed in London in 1903.

1850 CENSUS OF BEDFORD COUNTY, TENNESSEE (Transcribed and Published by Miss Deane Porch, Route 2, River Road, Nashville, Tennessee 37209. 374 pages. Price: \$12.00.)

This is a neatly done, easy to read book with an index. It gives the names of all persons living in the family on June 1, 1850, their age, sex, color, occupation, value of real estate owned and birth place. The introduction gives a brief history of the county. Every genealogist knows the value of such a book.

HISTORY OF THE DODSON-DOTSON FAMILY (Supplement. Order from The Rev. Silas Emmett Lucas, Jr., 405 Virginia Way, Vidalia, Georgia 30474.)

The Rev. Lucas has compiled and edited a supplement to the HISTORY OF THE DODSON - DOTSON FAMILY which he published earlier. He considers this a reference work book of this family in the southeastern part of the U.S. It consists of 113 pages of families with deeds, wills etc. While there is a family index, there is no index of the names of affiliated families. Price: Paper Cover \$10.00, Hard Cover \$12.50.

THE HUTCHENSON FAMILY OF MECKLENBURG COUNTY, VIRGINIA (By Herbert F. Hutcheson. Order from Mr. Herbert F. Hutcheson, P.O. Box 23, Boydtown, Virginia 23917. 87 pages. Indexed. Price: \$8.00.)

This is a hard-back, cloth-bound book containing six pages of marriages, recorded with surety names, those giving consent, minister and other information when available; family chart; extracts from family letters and wills. It begins with the immigrant, William Hutcheson, who arrived in Virginia on the ship, Diana, in 1618 and brings the family up to the present. There are 245 allied family names given.

THE STRINGER FAMILY AND KIN (By Alvin Ward Vogtle, 1444 Timberlane Drive, Birmingham, Alabama 35213.)

This, the sixth printing of Stringer Family Records, includes Brinson, Williams,

Armstrong, Culpepper and other family names on a well documented chart on excellent quality paper, along with family pictures. Those interested in the Stringer genealogy would do well to contact the author as he is making a most generous offer.

JOHN GRANBERY, VIRGINIA (By Julian Hastings Granbery. Order from Mrs. Alice Granbery Walter, 275 Victoria Pl., Lawrence, N.Y. 11559. 349 pages. Price: \$20.00 to libraries, \$25.00 to individuals.)

This is one of the most remarkable family histories that I have had the privilege of studying in a long time. The preponderance of material reflects the numerous hours and the interminable miles traveled to secure documentary proof by the compiler, Julian Hastings Granbery. He began the family research in 1894 at the age of 21 years and pursued it relentlessly until his death at the age of 88 years. At the time of his death, the manuscript was completed; but later, his daughter, Alice Granbery Walter, added an appendix of some 1500 names, bringing the various lines to date as far as possible. It is written in narrative form, making it easy to follow. The Allied families are treated with the proper respect and not glossed over lightly. The neophyte genealogist can trace any family because there is not only a name index but also a numerical descendant index as well as a place and subject index. Fastened to the back of this hard-back, bound volume is a pocket which contains maps and charts. The book is filled with valuable information on the Granbery and other families.

THE DESCENDANTS OF JONAS & FRANCES MEADOR (Order from Major Perkins Nunnally, 3612 Poplar Street, Pine Bluff, Arkansas 71601. Price: \$3.50.)

This is a sequel of a former book published in 1965 by the title, "The Meador Lineage of Julia Ann Meador." This sequel is in narrative form and traces the families through the various counties of Virginia into Kentucky, Tennessee and Missouri. It contains 46 pages of well documented material, as one would expect, as the author is a certified genealogist. I understand there are only 25 copies left and there will be no more when they are gone.

THE HARRIS PAPERS, Volume 3 (By Mrs. Kathryn Wiggins, 1642 Calle La Cumbre, Camarillo, California 93010. Price: \$5.00.)

This volume of Mrs. Wiggins' compilations includes land grants, and patents 1623-1725, Headrights, Wills, Deeds etc. of Harris families living in James City, Surry, Southampton, Charles City and Lunenburg Counties, Virginia. Allied family names as well as grantors, grantees and names of persons who had adjoining property are mentioned. As this is an accumulation of miscellaneous information, your Harris ancestor could be found here.

RESEARCHING THE FAMILY HISTORY FOR BEGINNERS (By Richard E. Holben. Order from Family History, P.O. Box 8572, Albuquerque, New Mexico 87108. 24 pages. Price: \$1.00 or in lots of ten, 55 cents postpaid.)

This booklet charts ancestors, methods of searching, preparation of material and

available sources of data. It is primarily intended for the novice.

**OLD CHEROKEE FAMILIES** (By Emmett Starr, indexed by J.J. Hill. Order from University of Oklahoma Foundation, Oklahoma Memorial Union Bldg., Mz. 3, 900 Asp Avenue, Norman, Oklahoma 73069. Price: \$3.95.)

This is a reprint of the history of 39 old Cherokee families and their genealogies who were of mixed blood and important to the history of the Cherokee Nation with their hundreds of affiliated families. There is a 90-page index. It will require some serious study of the instruction in the front of the book to be able to trace a family. Once this is accomplished, you will probably be disappointed as there are no dates given even to let one hazard a guess as to the time of birth, death or marriage of the person one is trying to trace. While it is a very interesting book, it is frustrating to the genealogist because there are so few dates.

**RICHLAND COUNTY, ILLINOIS, CEMETERY INSCRIPTIONS** (Order from Mrs. Barbara J. Craddock, 2 Hunley Drive, Olney, Illinois 62450, the compiler. Hard back, cloth binding with gold lettering. Price: \$15.00.)

The author has carefully transcribed over 15,000 inscriptions for the surname, given name, date of birth and death, age and family relationship when possible with particular attention given to military service. Olney is the County seat. Directions are given to the various Cemeteries and maps of the Cemetery, divided into sections to facilitate the locating of graves.

**PRINCE GEORGE COUNTY, MARYLAND, 1800 CENSUS** (Order from Maryland Genealogical Society, 213 South Rolling Road, Cantonsville, Maryland 21228. Price: \$4.00.)

To find an 1800 census is rare indeed, but to find one printed in offset type, alphabetized and easy to read is a welcome surprise. In the introduction, there is a brief history of the county and suggestions as to where one might find other Maryland genealogical records.

**THE SLAGLE FAMILY IN AMERICA DESCENDED FROM THE SCHLEGEL VON GOTTIEBEN FAMILY OF GERMANY** (By Karl Fredrich von Frank. English translation by George A. Bingle and William B. Marye. Order from A. Russell Slagle, 312-A Wyndhurst Avenue, Baltimore, Maryland 21210. Price: \$7.50.)

This is a handsome volume with off-white, hard-back binding decorated with the book-plate of AUGUST WILHELM SCHLEGEL in color. It is printed on good slick paper, well documented and with many family portraits. It begins with the family in 1400 in Germany or Saxony and brings it up to the present through the immigrant CHRISTOPHER SCHLEGEL born 20 Oct. 1676 in Germany and was in Germantown, Pa. 1700. This book is unique in that it is really two complete volumes in one. The first part is the English translation and the second is in German. To the novice, the system of using cardinal numbers for the day, Roman numerals for the month and cardinal numbers for the year, in the dates may be confusing at first sight.

**COURT RECORDS OF HICKMAN COUNTY, TENNESSEE, 1833-1856** (Compiled by Kate and Paul Leeper. Order from Mr. or Mrs. H.P. Leeper, 3324 Fairmont Drive, Nashville, Tenn. 37203. Price: \$5.00 plus 25¢ postage.)

This book contains 100 pages, mimeographed with over 800 names all indexed. There is the petition to the State Legislature, 1813; Circuit Court Docket Book of Hickman County, 1833-1839, with extra data on all names appearing in the Docket Book which are shown in 1820 census. It also has the Guardians' reports 1844-1846; Chancery Court Rules Docket, 1856 and Henry Nixon's Day Book 1856. It seems to have

covered the court records of this period except the Probate and settlement of estates.

PENNINGTON PEDIGREES, VOL. I (Order from Mrs. Bee Holmes, 1508 Yows Street, Borger, Texas 79007.)

This is a group project for Pennington families everywhere, and they propose to publish four volumes per year, each to sell for \$2.00 per volume. Mr. William Perry Johnson, Editor of the Journal of North Carolina Genealogy, is the family genealogist, and this should assure everyone of the quality of information. Each volume will contain approximately 100 pages plus index.

S Q U A H is the unusual name for a new newsletter sent out by Adelle Whitby Olney, 2325 Blake St., San Bernadino, California 92405. This 96-page collection of unrelated family histories spans the country and includes charts, cemetery records, correspondence and other valuable data collected by the writer. In order that this material may be shared with our readers, a two-page index to these records will soon be published. Thank you, Mrs. Olney, for including us in your list of receivers.

JASPER COUNTY, GEORGIA CEMETERY AND BIBLE RECORDS (Compiled by Mrs. Edgar M. Lancaster, 1969. 373 pages. Index. Mimeograph. Order from the compiler at Shady Dale, Georgia 31085. Price: \$12.50.)

With its neat index, and lovely Jasper County map, the genealogist should find this book a definite help in locating the burial locations of the folks who have lived in this Georgia County. The compiler has been careful to give the full dates from the tombstones (all located in the proper cemetery grouping) with family information included that was engraved on the stones. The Bible abstracts are as well prepared as the cemetery records; many of them are quite old. A better than average county records abstract book.

## WILLIAM BOYD

William Boyd, a son of George Boyd, was born in Orange Co., N.C. on March 15, 1761. His first wife was Mary Wasson. He had two sons by Mary Wasson—Henry S. Boyd and John Boyd. He married his second wife, Nancy Small, on Feb. 7, 1833 in Roane Co., Tenn., and he was living with her at the date of his death, Feb. 14, 1847.

William Boyd entered the services of the United States during the Revolutionary War from Orange Co., N.C. and served under Captain John Walker for six months as a private. He was attached to the second regiment commanded by Colonel Alfred Moore. After he was discharged, he moved to Surrey Co., N.C. and later volunteered for another six months. During this second period of service, he served under Captain William Shepherd and General Rutherford. At the end of this second period of service, he returned to his home in Surrey Co. After a short time, he volunteered again for a three-month term and served under Captain Joseph Bland. He was attached to the regiment commanded by Colonel Blanchard and General Campbell. During this last term of service, he was "marched to Kings Mountain, N.C., where they had a severe battle defeated the army and took them practically all prisoners." After this third period of military service, he again returned to his home in Surrey Co. and remained there about four years. He later lived in Holston, Tenn.; Roan Co., N.C.; Lincoln Co., N.C.; Buncomb Co., N.C.; Anderson Co., Tenn.; Warren Co., Tenn.; Jackson Co., Ala; again in Warren Co., Tenn.; and finally in Roane Co., Tenn., where he resided until his death, Feb. 14, 1847.

A complete file of the Revolutionary War Record of William Boyd can be found in File S45878 and can be obtained from the National Archives and Records Service, General Services Administration, Washington, D.C.

Henry S. Boyd, a son of William Boyd, was born April 17, 1780 and died April 21, 1856. He married Susannah M. Baumgartner who was born Feb. 19, 1784 and died Sept. 9, 1858. A daughter of Henry S. Boyd and Susannah Baumgartner Boyd, Mary Wahoo Boyd was born Dec. 30, 1826 and died April 7, 1901. She married Joshua Christenberry who was born Nov. 1, 1819 and died July 26, 1874. For more detailed information on the family of Henry S. Boyd, see National File 444498, Mrs. Carol Christenberry Greer, of the Daughters of The American Revolution.

Dr. Walter McClain in his HISTORY OF PUTNAM COUNTY, TENNESSEE, states: "William Boyd of Virginia but later from North Carolina, settled near Knoxville, this State, where he resided until his death. His son, John Boyd, born in North Carolina, Dec. 9, 1777, and Elizabeth Leath, born in Virginia, Aug. 29, 1785, were married in Anderson County, Tennessee Dec. 16, 1801, and at once set out to locate in the new Cumberland country.

"John Boyd entered a large tract of fine farming land in Rock Springs Valley, now the 11th civil district of Putnam county, and erected a large two-story log house, weather-boarded and ceiled throughout with hand-made lumber - an unusual house in its day. In this house John and Elizabeth Boyd reared their large family of fourteen children - seven sons and seven daughters - thirteen of whom lived to marry and rear families of their own. John Boyd volunteered in the War of 1812 in Capt. John Sutton's company of Tennessee Militia, and fought at New Orleans under Gen. Andrew Jackson." On this 24th day of October 1832 personally appeared in open court before William B. Clark, John Catron & William Galbreath, Justices, now sitting it being a court of Record having a clerk and seal William Boyd a resident of the county of Roane & State of Tennessee aged 71 years the 15 of March next who being first duly sworn according to law, doth on his oath, make the following declaration in order to obtain the benefit of the act of congress passed June 7th 1832 that he entered the service of the United States under the following named officers and served as herein stated, applicant resided in Orange County, North Carolina when he entered the service of the United States applicant entered under Captain John Walker for the term of six months as a private, applicant was attached to the second regiment commanded by Colonel Alfred Moore. Applicant was marched from Orange County to Wilmington where he was stationed for the term of six months. Applicant was in an engagement at Moors Bridge on a small river called black water against the tories that Caswell was a militia general who commanded at the engagement that after the engagement applicant was marched back to Wilmington where he remained until he was discharged. Applicant then went home then moved to Mecklinburgh County where he remained until he volunteered under Captain John Merritt Alexander for the term of three months, was attached to Colonel Franklin Locks & General Griffith Rutherfords regiment. Applicant was marched from Mecklinburgh through Burke County, then cross the mountains at the head waters of Swanannoa into the Cherokee country, traversed the cherokee country, burnt the lower town, middle towns and many other small towns belonging to the indians, had a small engagement between the said towns with the indians & killed a good many indians, after routing and subduing, was marched back to Mecklinburgh County where he was discharged after serving three months as volunteer, applicant then moved to Surrey County, where he volunteered for six months under Captain William Shipton in the regiment commanded by James Shepherd & General Rutherford, was marched from Surrey County to Savannah Town in South Carolina, from there to the magazine on Savannah river where applicant was stationed for the balance of the six months, was then discharged by Captain Smith. Applicant then went home to Surrey County where he remained a short time, then volunteered again for three months under Captain Joseph Bland was attached to the regiment commanded by Col. Blanchard & then joined General Campbell, was marched to Kings Mountain, North Carolina, where they had a severe battle, defeated the army and took them practically all prisoners. That Maj. Good also was one of the commanding generals, applicant then was marched to the moravian town, with the prisoners and there stationed until applicant was discharged after serving three months, then went home to Surrey County where he continued to reside about 4 years, then moved over on Holston Tennessee where he staid a short time then moved back to North Carolina Roan County where he remained about one year then moved to Lincoln County, N.C. where he resided about 2 years then moved to Buncomb Cty, where he resided about three years then moved to Anderson County, Tennessee, where he resided about 8 years, then moved to Warren Cty. Tennessee, resided in said county about 2 years, then moved to Jackson County, Alabama where resided one year then moved back to Warren, remained there about 6 months, then moved to Roane County where he has resided ever since. Applicant was born in Orange County, North Carolina in the 1761, applicant in all a 12 months as a malitiaman besides 6 months as a regular, applicant has no documentary evidence of his service as he has long since lost his discharge, nor does he know of any person living by whom he can prove his service. Applicant states that Jessie Mitchell, Morris Mitchell (who is a minister of the gospel but applicant could not get him to court) George W. Duke, John Prichett, Drury Smith, Elijah Mitchell & Stephen Mitchell are neighbors of applicant who could testify that applicant is a man of verasity that he is entitled to credit and that they believe that he served as a soldier in the revolution in the manner as above stated, applicant has no record of his age, but knows it from the account that his parents gave him. He hereby relinquishes every claim whatever to a pension or annuity except the present and declares that his name is not on the pension roll of the agency of any other state. Pages 284-301      June Term 1827

James Coody vs William Hartley and William Spence

Coody made bond to prosecute his case 6 Sept. 1826 with Jesse Byrd his security.

To the Honorable the Chancellor of the Chancery Court held at Kingston....your Orator, James Coody, a native of the Cherokee Nation of Indians, but now a resident of the County of Roane...that in pursuance of the treaty between the United States and the said Cherokee Nation of Indians, concluded at the City of Washington 27 Feb. 1819, your Orator took a life reservation of 640 acres of land in Roane County on the south side of the Tennessee River opposite the first Island above the mouth of Clinch River. In the year 1820 a certain William Hartley settled on part of the land...(Leased to Hartley at first, 50 acres then in 1824 a new lease to include 160 acres, claiming that he thought he had only leased 50 acres.)...said Hartley has lately sued your Orator, by warrant, before a certain Thomas Blake, Justice for Roane County...notes written by William Spence a citizen of Roane County...

Answer of William Spence filed 16 Sept. 1826...some time in 1821, complainant and William Hartley came to his residence upon the round Island in the Tennessee River...for him to draw an article of lease for 50 acres...part of said reservation...asked to bring the lease to the reservation, which he did on 29 Jan. 1824...wrote a new agreement...witnessed by John Hartley...in the spring of 1825...Coody and Hartley came to the house of this respondent on Pond Creek (shows that he had moved from the round island)...and stayed all night...made five notes for \$100. each from Coody to Hartley by way of indemnity which would never be collected as long as Hartley held a peacable lease on his part of the reservation...

Answer of William Hartley filed 2 Nov. 1826....this Respondent did settle upon part of the reservation of James Coody... admits the two leases...(Was about to move away to establish on some land where he might have a good title)...Coody offered to sell to him the land as a 99 year lease...year 1824....Complainant and his family consisting of himself, a wife and three children...owed this Respondent...William Spence did then and there at a sugar camp on the reservation where Coody and his wife were boiling sugar set down and drew out the article of agreement...a certain Jesse and Joseph Byrd esquires...influencing Coody to take the land back from Hartley...Coody agreed to give his five notes of indemnity....The land was levied on for the taxes not paid by Coody...Allen Pride was the purchaser...Hartley sued Coody on the notes...

Amended answer of William Hartley filed 14 Dec. 1826...the persons present when the lease for 160 acres was made at the aforesaid sugar camp were himself, James Coody, John Hartley, William Spence, also James Coody's wife was present and two of Respondent's daughters, Peggy and Polly were also present...

In another place William Hartley named his family as wife and daughters Peggy and Polly Hartley.

The case was dismissed by the Court.

Pages 301-324      June Term 1827

Richard Luallen vs William Hogshead

Luallen made his bond to prosecute his case 13 Aug. 1824 with John Williams his security.

To the Honorable Judge of the Court of Chancery....your Orator, Richard Luallen, a citizen of Anderson County...Tennessee...that on 18 Feb. 1801 he entered into articles of agreement with a certain Robert Houston, who was a lawyer agent of Robert Burton of North Carolina for the purchase of a tract of land situated within Henderson Co. Clinch survey and now within the County of Anderson...paid...Robert Burton on 26 Jan. 1804 for himself and as attorney for Archibald Henderson executed to your Orator a deed...110 acres...has continued in possession of said land....On 2 July 1800 Robert Burton entered into articles of agreement with a certain William Hogshead...100 acres...adjoining your Orator's land on the Clinch River...(The whole dispute is about the overlapping of the surveys and who had title to a little river bottom.) Robert Burton is now a very old and infirm man...Robert Houston, witness to a second deed, is liable to die...

Exhibit A - Deed...Robert Houston as attorney for Robert Burton executor of the estate of Richard Henderson deceased...110 acres...\$300...sold to Richard Lew Allen(sic) the following bounds of land within the Henderson & Clinch survey...to Benjamin Parker's line...corner to William Hogshead...18 Feb. 1801...

Answer of William Hogshead filed 18 Mar. 1825...that in June 1800 Robert Burton... employed this defendant as a surveyor to run out and divide land for him in Powells Valley and on Clinch river in what is called Henderson and Co. Grant...defendant shortly before that time having removed from Virginia and settled on the Clinch river within the south west/ half of Lott H within said grant which half lot appears to have been allotted to the heirs of the said Richard Henderson by a deed of partition made between the several proprietors thereof...2 July 1800 Burton made a contract to sell to this defendant the land on which he was living...in October 1800 about the time said Burton was leaving this country for North Carolina....asked Burton for his deed... Robert Houston drew the deed...witnessed by Lewis Cox and Henry Breazeale....later a certain Walter Evans surveyed the land...(Josiah Watson's land mentioned in the grant.) ...a second deed written witnessed by Jesse Sharp...Complainant had a sister named Barbery...a certain Thomas H. Paine who was then teaching school in the neighborhood drew a deed with John McAdoo a witness...

Although both men held deeds covering the land in dispute, William Hogshead's deed was dated prior to that of Richard Luallen and he was awarded the land.
