Some of you asked us to publish more articles about various counties; we checked previous volumes of our magazine, and some counties had been covered. A Table of Contents for back issues is available for \$1.00 and a SASE. Information about counties of interest to you may have been printed. Some county records are not extant; they were destroyed by fire or lost in other disasters. Some counties were organized fairly late--Cheatham County in 1856, for example. Your ideas and opinions are always welcome; when it is possible, information you request will be published. If you know about data sources on Tennessee counties or early residents, let us hear from you.

We need your help! When you write to the Tennessee Genealogical Society, please use a separate, full-size sheet of paper for each subject; and include your name on each sheet. Our mail is handled by several people who cut off the portion of your letter that pertains to their department. This means that sometimes only a small scrap of paper will be left for the Query Editor who has the impossible chore of trying to figure out what you want to know. When you send a query, please type or print it; tell us what you want to find out, and be sure to check dates, names, relationships and locations; this will let us abbreviate and edit your query to avoid possible interpretation errors.

The National Archives and Records Service Regional Archives Branches now have available for public use the following complete sets of microfilm publications relating to Revolutionary War service: M804, Revolutionary War Pension and Bounty-Land Warrent Application Files, 1800-1900; M881, Compiled Service Records of Soldiers Who Served in the American Army During the Revolutionary War; and M860, General Index to Compiled Service Records of Revolutionary War Soldiers. Lists of other National Archives and Records Service microfilm publications are also available on request.

## BOOK REVIEWS

GENEALOGICAL RESEARCH DIRECTORY MID 1984 edited by Keith A. Johnson and Malcolm R. Sainty. 1984. Soft back. 454 pp. Order from Mrs. Netti Schreiner-Yantis, 6818 Lois Dr., Springfield, VA 22150. \$13.50.

The G. R. D. is an important international research tool not only because the contributors live in twenty different nations, but because their entries touch on no fewer than 58 countries. Yet the Directory is just as useful for local research, for a contributor may discover that a previously unknown distant relative resides nearby. The Directory lists in alphabetical order the family name being researched, the time period and place. Each entry then refers the reader to the name and address of the contributor. By corresponding with the contributor, much useful data may be exchanged by family historians.

TOMBSTONE INSCRIPTIONS Shenandoah and Page Counties, Virginia by Duane L. Borden. 1984. 342 pp. Soft back. Indexed. Order from Mr. Borden, 5995 W. Arizona Ave., Denver, CO 80226. \$25.00.

This publication of cemeteries is divided into three sections. In Section I, inscriptions are transcribed from 141 church, community, and family cemeteries, located generally within a 15-20 mile radius of Woodstock in Shenandoah County. Some cemeteries are located near the borders of adjacent counties in West Virginia. In Section II is found information from thirty-four cemeteries of Page County. They are located mostly along the east border of Shenandoah County and along the south fork of Shenandoah River. Section III contains records from twelve cemeteries located in Rockingham, Clarke, Page, and Warren Counties which abut Shenandoah County. The compiler has enlisted the aid of numerous Virginians who have named some persons known to have been buried in a given spot where no marker now exists. Much local history has been added to the descriptive locations which precede each listing.

VIRGINIA CHASTAINS GENEALOGY AND FAMILY HISTORY by Lowell B. Chastain. 1983. Soft back. 215 pp. Order from Mr. Chastain, 331 N. Locust St., Elizabethtown, PA 17022. \$15.86.

CHASTAIN KITH AND KIN by Mary Avilla Abel Hall Farnsworth-Milligan. 1981. Hard back. 402 pp. Indexed. Order from Mr. Chastain, as above. \$28.75

The Virginia Chastain genealogy begins the story of French Huguenot Refugees who arrived at Jamestown, Virginia in 1700. A list of refugees contains the names Estienne and Pierre Chastain. Pierre settled at Manakin Town and had many descendants. The author has searched in many states and counties to gather in this book a tremendous amount of information. Counties of Virginia are listed alphabetically, giving any Chastain records found there; counties having no Chastain information are noted. Tombstone inscriptions are given for Chastains in Arlington National Cemetery and some cemeteries in Indiana, Kentucky, and Arkansas.

Kith and Kin is a revised Chastain section from the 1973 edition of Kith and Kin of Georgia Ridge by Avilla Farnsworth-Milligan. It expands several branches of Pierre Chastain descendants. Estienne (Stephen) Chastain left no male heir. Pierre and his first two sons, Jean and Pierre Jr., lived out their lives in Virginia. The third son, Rene, moved on to South Carolina. By the third generation the trend to move onward to the west and southwest was prevalent, and many more continued to move with each new generation. Several Chastain families went to the Carolinas, Kentucky, Georgia and Tennessee

THE ANCESTORS and DESCENDANTS of JOHN WHITE and SARAH ELIZABETH GREEN With Allied Lines by Anne White Strawn. 1984. Hard back. 472 pp. Indexed. Order from Mrs. J. Boyd Strawn, 220 Briarcliff Rd., Spartanburg, SC 29301. \$29.00.

This 8x11 inch book is a carefully documented genealogy of several prominent families of early South Carolina: White, Green and allied families of Barton, Potts, Witherspoon, Wigfall, Tenhet and others. Much historical information from published and unpublished records is presented with a combination of beautiful pictures, pedigree charts, maps, family group sheets, documentation chart, and list of sources. The first three chapters cover John and Sarah Green White and their ancestors. The next five chapters deal with the descendants of their children, Sarah Wilson White, William Capers White, Richard Green White, James Benjamin White and Anne White. Over 2,800 people in the full name index promises to make this volume interesting and most informative.

LAUDERDALE COUNTY, TENNESSEE 1840 CENSUS, 1850 CENSUS, and 1850 MORTALITY SCHEDULE by Bettie Brandon Davis. 1983. Soft back. 65 pp. Indexed. Order from Mrs. Davis, 1610 Wheaton, Memphis, TN 38117. \$7.50.

This work contains all information on the first census (1840) for Lauderdale County, TN and lists names of heads of household with number and approximate ages of both free and slave members. It gives all of the data which appears on the census relative to occupations and professions represented there. The transcription of the 1850 census lists every free person in each household showing all of the data given on the census sheet - a verbatim copy. The 1850 Mortality Schedule lists name, age, sex, color, marital status, place of birth, month of death, profession, cause of death, and length of illness of all who died from June 1, 1849 to June 1, 1850. An 1838 map shows original civil districts; a 1964 map is given for comparison.

SUMNER COUNTY, TENNESSEE INVENTORIES, SETTLEMENTS, AND GUARDIAN ACCOUNTS Volume A MARCH 1808-FEBRUARY 1821 abstracted by Mrs. Gale Williams Bamman and Mrs. Debbie Williams Spero. 1984. Soft back. 79 pp. Indexed. Order from Mrs. Bamman, P.O. Box 8161, Nashville, TN 37207. \$12.25.

This volume is an index to those earliest probate records of Sumner County, Tennessee. Although Sumner's will survive from 1788, the first surviving book of inventories, settlements, and guardian accounts dates only from March 1808. Included in the full name index of 1,200 plus names are names of the deceased, administrators and executors, guardians of minor heirs, names of minor heirs, legatees and devisees. Names of buyers at sales were omitted, except those of the same surname as that of the deceased or heirs or executors; all female names are listed since it was unusual for a female to be a buyer at a sale.

HENRY RICE (1717-1818) THE PIONEER TENNESSEE GRISTMILLER And His Twelve Children by Melvin Weaver Little. 1983. Soft back. 312 pp. Indexed. Order from Mr. Little, 924 20th St., Arlington, VA 22202. \$18.00.

Henry Rice was born in Hanover County, Virginia and married there and lived later in South Carolina and East Tennessee. The name of his wife (or wives) is not known, but his children are William, Charles, James, Daniel, John, Levi, Martha (Peggy), Molly, Anna, Rosa, Lavinia, and Elizabeth. With some of his older children, Henry moved to Watauga Settlement in East Tennessee where he built and fortified a large gristmill. He spent the rest of his 101 years at Lost Creek, near Kingsport in present Hawkins County. The mill was used as a fort during Indian trouble and is presently a landmark in the state. An appendix contains copies of maps, Bible records, South Carolina land grants, and military records.

A HISTORY OF METHODISM IN ALABAMA by Anson West. 1893, reprint 1983. Hard back. 796 pp. Indexed. Order from The Reprint Company, P.O. Box 5401, Spartanburg, SC 29304. \$30.00.

This extremely informative volume was reprinted for the bicentennial celebration of the founding of the Methodist Church in America. It has been called the authoritative source on Methodism in Alabama but is not limited to that state alone. Western Florida was a part of the Alabama Conference, and in 1819 Tennessee, Mississippi and South Carolina furnished preachers for Alabama. It covers the first sixty years of the development of the church. It also is a genealogical source, containing much personal information about both clergy and lay persons, as well as names of members of churches. Some of the topics covered are first white settlements, appointments, circuits, missions to the Indians, education, and much, much more.

FOUR CENTURIES ON THE PASCAGOULA Vol. I and II by Cyril Edward Cain. 1953, reprint 1983 as a set. Hard back. Vol. I, 216 pp. Vol. II, 255 pp. Indexed. Order from The Reprint Company, P.O. Box 5401, Spartanburg, SC 29304. \$24.00 each or \$48.00 for the set.

The existing written and legendary material on the Pascagoula River Valley has been brought together in Volume I and is subtitled History, Story and Legend. It covers the history of the territory, Jackson and George Counties, Mississippi, up to 1817. Early land claims and early census records, and a list of early postmasters are also presented here. Part I of Volume II covers the history of the region from 1812 to 1960. Part II of the later volume is devoted to genealogy: names of immigrants, the census of 1850, families of 1860, cemetery records, and Bible records. Three courthouse fires in Jackson County make this volume particularly useful.

OUR FRENCH-CANADIAN ANCESTORS by Thomas J. Laforest. 1983. Soft back. 245 pp. Indexed. Order from The LIST Press, P. O. Box 1063, Palm Harbor, FL 33563. \$12.00.

OUR FRENCH-CANADIAN ANCESTORS, an English version of NOS ANCETRES by Father Gerard Lebel, is the first of a series intended for those descendants who have migrated far afield, but especially for those who may no longer be conversant in French. The twenty-four forefathers of the families comprising this volume emigrated from France to Canada in the seventeenth century. Their stories, first told in the SAINT ANN REVIEW in French, have been augmented, corrected and brought up to date. Mr. Laforest did not tamper with the names of people or places; he included many maps, a Glossary of French words and phrases, a Bibliography and an Index of Names. This well-documented book has family sketches on Audet, Blais, Couture, Deblosis, Dionne, Gagnon, Lavergne, Levesque, Pequin, Paradia, Pothier, Rheame, Rondeau, Savard, Trudeau, Vachon, and others.

GUIDE TO THE MICROFILMED MANUSCRIPT HOLDINGS OF THE TENNESSEE STATE LIBRARY AND ARCHIVES by The Tennessee State Library & Archives, Department of State. 1983. Soft back. About 200 pp. Indexed. Order from The Tennessee State Library & Archives, Archives and Manuscripts Section, 403 Seventh Ave., N., Nashville, TN 37219. \$7.00.

This 3rd edition of the GUIDE describes each group of records which has been microfilmed by the TN Archives; it includes many new films added since the 1978 edition. A number has been assigned to each manuscript or group of records, inclusive dates noted, number of items and reels of film stated, followed by a brief description of the content of the film. An example is:

24 - CHURCH RECORDS. BETHBIREI PRESBYTERIAN CHURCH, MARSHALL COUNTY, TN 1827-1910. 2 items, 1 vol. 1 reel. Church records consisting of the constitution and records of the Sabbath School 1827-41; etc.

Most of the film is available on interlibrary loan, and most large libraries have a copy of the GUIDE, but the convenience of having one at hand in a home library is well worth the price.

WEAKLEY COUNTY, TENNESSEE MARRIAGES Vol. II, SEPT 4, 1863 - 1878 compiled by the Weakley County Genealogical Society. 1984. Soft back. 144 pp. Indexed. Order from the Weakley County Genealogical Society, P.O. Box 92, Martin, TN 38237. \$12.00.

This volume is a continuation of the society's previous work, and all entries were copied from official records kept by the County Court Clerk of Weakley County at Dresden, Tennessee. Entries include the names of the groom, bride, officiant and the date indicated on the returns. The entries are in alphabetical order by the surname of the groom. Brides names are indexed, giving name of groom rather than page number. This 8x11 volume is a welcome addition to libraries of Tennessee researchers.

A BEDWELL FAMILY by Lary King. 1982. Hard back. 377 pp. Indexed. Order from the author, 100 Longview Dr.-Longview Acres, Hendersonville, TN 37075. \$25.00.

Robert Bedwell, Sr. (1635-1686) is the common ancestor of all Bedwell descendants shown in this book. From St. Giles Parish, Cripplegate, London, England in 1635 to all fifty United States of America and many foreign countries in 1982, the author has thoroughly covered fourteen generations. Upon the glossy pages of this beautifully bound book are some photographs but, most important, a wealth of information on Bedwell and allied lines. Each person is given a number which is preceded by the number of his generation, e.g. 9-678. A descriptive sentence or paragraph follows, giving all known data. Mr. King has done an outstanding job of documentation, and his numbering system is very easily followed.

HISTORY OF THE KERSHNER FAMILY (of Windsor Township, Berks County, Pennsylvania) by George C. Kershner and Ammon G. Kershner, M.D. 1972. Spiral bound. 146 pp. Order from The Kershner Family Association, 1449 Fox Run Dr., Charlotte, NC 28212. \$15.00.

This is a reprint of the original 1972 volume which ended with Appendix II, and covered Johannes, Conrad I, II, & III, John, John George Kershner and their descendants; land deeds, Coat-of-Arms and other early immigrants are added in Appendix I and II. To the preceding has been added Appendix III with additions and corrections to family data, charts, tax and ship lists, its own index and a surname index to the original volume.

HERRICK CENTENNIAL 1883-1983 (ILLINOIS) by Herrick Historical Society. 1983. Hard back. 173 pp. Indexed. Order from Mrs. Ralph Austin, Box 177, Herrick, IL 62431. \$18.00. Also available soft back without index or fold out plat map - \$13.00.

In commemoration of Herrick, Illinois' 100th birthday in 1983, the Herrick Historical Society produced this volume to highlight the area's past and present. In addition to the general history, there is an 18" x 24" fold out plat map showing land owners in 1875 southwestern Shelby County, Illinois and in 1891 northeastern Fayette County, Illinois. There are histories, including pictures, of over 150 families, some covering several generations and many having roots in Ohio, Kentucky, Tennessee, Virginia and other eastern states.

BLOUNT COUNTY, TENNESSEE MARRIAGES 1795-1910 1982. Hard back. 314 pp. \$27.00.

BLOUNT COUNTY, TENNESSEE CEMETERY RECORDS 1983. Hard back. 278 pp. Indexed. \$25.00. Order both volumes from Mrs. Edith Little, 411 Indiana Ave., Maryville, TN 37801.

Blount County marriages were copied in 1982 from original records in the Clerk's office and compared with Mr. Parham's list which was published in this magazine in 1980, Vol. 27, No. 1. Both brides' and grooms' names are cross-indexed alphabetically; officiants for each marriage are given, but witnesses and bondsmen have been omitted. There are 24,000 entries in all including 23 which were not on Mr. Parham's list and 19 which now are missing.

The cemetery records list all known adult graves in the original Blount County which includes parts of current Monroe and Loudon Counties; dates and family relationships are given where available. There are over two hundred cemeteries ranging in size from two or three graves to over six thousand. Locations of cemeteries are given on a map with directions for finding each. Also included is a list of Soldiers and Patriots of the Revolution buried in Blount County with dates, cemetery, state of service, and wife where known.

SOLDIERS OF THE WAR OF 1812 BURIED IN TENNESSEE by Mary Hardin McCown and Inez E. Burns. 1977. Soft back. 183 pp. \$15.00.

HISTORY OF BLOUNT COUNTY, TENNESSEE by Inez E. Burns. 1957. Hard back. 375 pp. Indexed. \$20.00. Order both volumes from Mrs. Edith Little, 411 Indiana Ave., Maryville, TN 37801.

Instead of issuing a supplement to the 1959 edition, it was decided to revise the entire book of soldiers of the War of 1812 who are buried in Tennessee. Material for this volume has been gathered from many places and contains over 1,900 soldiers with name of wife, dates, military service, and place of burial if known. The veterans are listed in alphabetical order. There is a list of veterans (including vital facts) who are buried in other states, but had descendants who were members of the Tennessee Society or were of military importance. Twenty pages of company lists are included along with an 1813 petition from Overton County.

A secondary title for the History of Blount County, Tennessee is From War Trail to Landing Strip and extends from 1795-1955. It is a well organized, comprehensive record of the county. Tax lists, muster rolls, county officials, early inns and watering places, churches, education, lawyers, medical men, and communities are some of the many topics covered. The chapters on early settlement and county government contain information from court minutes, newspapers, and J.G.M Ramsey's The Annals of Tennessee in the Eighteenth Century. Photographs of buildings and portraits of prominent citizens enhance this volume.

BURRIS ANCESTORS Vol. III compiled by Arthur Price Burris. 1984. 8½" x 11" spiral bound. 115 pp. Order from compiler, 3952 Ewing Ave. So., Minneapolis, MN 55410. \$10.00.

Volume III of Burris Ancestors continues the compilation of data on the families of Bailey, Merritt, Price, and Burris. These families are located mostly in the eastern states in the 1700's and 1800's with a possible Burris connection in Jackson County, Tennessee circa 1800. Some of the many associated families are Burgess, Knickerbocker, Brobst, Rathbun, Wardwell and Stamback. Pedigree charts, copies of data from other publications and copies of Bible and baptismal records form the body of this book.

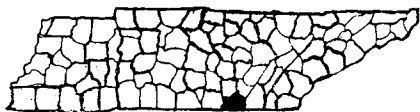

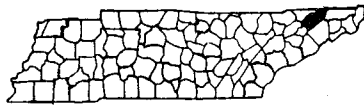

23 Feb 1838. He m/2 31 Oct 1839 Mary WITHERS, daughter of Sterling Withers of Sussex Co VA. Their daughter, Rosa Adella White, who m/1 John Donelson MARTIN and m/2 his brother, Andrew Jackson Martin, was the mother of Rosadelle Martin Weatherford.

One of the pages is a letter from an unidentified niece to one of David White's brothers. "Cousin Rosa" was Rosa Adella White. The letter reads:

Dear Uncle

Uncle David never made any entry in the Bible after his own marriage. The space on the first page I left for yours. Grandma does not remember the years of Uncles David and Williams death but thinks maybe you do. I regretted more than words can express not seeing you and Aunt last summer. Hope you will be sure and make us that promised visit in the spring. Remind Cousin Walker that she promised me one of sweet little John's (John D. Martin III) pictures. I know you will be better to have Cousin Rosa and her family with you again. Best love to all. Lovingly, Johnetta

JAMES HEMPHILL WILL - Submitted by William C. Pittman, 704 Desoto Rd. S.E.,  
Huntsville, AL 35801

James HEMPHILL, born 19 Nov 1749 in Londonderry, Ireland, came to America Aug 1767. He served in the American Revolution under Col. William BRATTON in the North Carolina militia, although his service was in South Carolina. He settled in the York District, South Carolina until 1815 when he moved to Williamson Co TN. In 1824 he moved to Lincoln Co TN where he was a resident when he filed a claim for a Revolutionary War Pension. His wife, Else, mentioned in the will, was Ealse Bratton, the daughter of Robert Bratton and niece of Col. William Bratton.

The will, dated 13 Feb 1836 Lincoln Co TN and proven in Court 4 Jun 1839 Marshall Co TN, divides his land and property between his wife, Else, and children, James, Jesse and Margaret. He bequeathed two dollars each to sons, John, William, Robert and Nathan, and daughters, Esther, Jane BELL, Martha WILLIAMS and Mary McNIGHT. After naming his son-in-law, James Bell, and son, James Hemphill, joint executors, he signed the will which was witnessed by A. ROSEBOROUGH and John ANDERSON.

Even though there have been no grave stones found for James and Ealse Hemphill, Mr. Pittman believes they may be among the unmarked graves in the Bell-Hemphill Cemetery in Marshall Co TN.

RENEAU LETTERS - Submitted by Mrs. McAlister Elliott, 8323 Sunbury Drive,  
St. Louis, MO 63136

The correspondence of the Rev. Isaac Tipton RENEAU is located in the West Virginia University Library. He was a preacher throughout Kentucky and Tennessee in the 19th century. The Rev. Reneau, born 1805 Clinton Co KY (then Cumberland Co), was a son of Elizabeth THURMAN and John Reneau. John was the son of Charles and Elizabeth (TIPTON) Reneau of Carter Co TN. Elizabeth Thurman was the daughter of Thomas Thurman and granddaughter of John Thurman of Clinton Co KY and Overton Co TN. The Rev. Reneau married Mary G. WOODS 22 Aug 1837; their children were Margaret Eunice

born 12 Jul 1839, Thomas Wood born 26 Jan 1842 and Isaac Tipton Alexander born 11 Mar 1859. Margaret married E. F. STILLINGS.

LETTER #3 - 8 Dec 1878 from Nathaniel Smith Reneau (brother of I. T. Reneau) to their sister, Mrs. Sallie S. STOVER, telling of death of his daughter and last surviving child, Sallie Eola Reneau, while a volunteer nurse in the Yellow Fever Epidemic of 1878 at Germantown, TN.

Also included among these letters is much Kentucky information on the Reneau family and their connections. The only Tennessee item comes from Elijah Stover's papers - 9 Aug 1875 - By will of Lewis Stover, Sr. Elijah Stover is deeded part of his land on Eagle Creek in Overton Co TN. Heirs were James Stover, Hiram Stover, Lewis Stover, Catherine Stover, the widow of Joseph Stover, and Elizabeth Stover, the widow of John Stover.

McDANIEL-BLAKELY FAMILY FROM SC TO TN,AL,MS - Contributed by Jeanne Ridgway Bigger

This 16-page article cites sources and give voluminous details and references. The entire article is on file in the Tennessee Genealogical Society Library. The following is an abstract given to aid in identifying the families.

Charles Edward McDANIEL - born c1814 TN (probably Franklin Co) married in Alabama (probably Blount Co) about 1834 to Jane Catherine BLAKELY, born c1814 Franklin Co TN. Her parents were John Blakely, Jr. and Kissiah HALCOMB. They had moved west from Laurens District, SC in 1810 with Sarah Green Halcomb, widow of Caleb and mother of Kissiah. Charles and Jane McDaniel had three children born in Alabama, Emily Amanda born 1835, William L. born 1837 and John born 1838-40. Two were born in Tishomingo Co MS, Elihu Christopher or Criswell 10 Nov 1843 and Mary born 1845. Mary is believed to have married Thomas H. RICHARDS and raised a family in McNairy Co TN.

Jane McDaniel died 12 Mar 1847 and Charles married c1849 Lydia HORN of Charlotte, NC. Their children, born in McNairy Co TN, were James Edward born 1850, Elijah Elkins born 1851 and David born c1854.

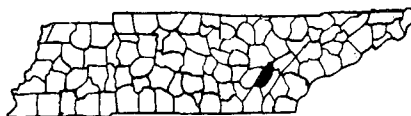
