

FROM THE EDITOR

As September begins, we have had a quiet summer at the TGS as we prepare for the move to Germantown in October. I know that many of us will miss the brick house in the woods, the fall leaves, and stepping on hickory nuts and pecans on our way up the boxwood-lined walk to the front door, even though we will be going to wonderful new facilities.

In the first two issues, we have tried to respond to the wishes of those who responded to our survey last year in an ongoing effort to improve <u>Ansearchin' News</u>. We heard from about 30 members, most from out of state and over the age of 55. A majority of respondents always read the feature articles, book reviews, queries and gleanings, while only occasionally reading comings and goings, marriages and deaths excerpted from Tennessee newspapers. Some never read the latter. Readers want to see more abstracts of Tennessee records, family histories, cemetery/burial records, Tennessee Civil War information, and articles on web sites, in spite of the fact that only half of this group uses the Internet for research at this time. Not a single reader wanted crossword puzzles or cartoons, and all said "Please, less blank space."

We are not including Tennessee marriages, deaths, comings and goings for the time being, since much of this material is available in libraries and in newspaper archives. We do feel that the Gleanings are useful to many (mention of Tennesseeans in journals from other states), and will always include Tennessee-related queries and book reviews as space permits. And we always welcome family histories, especially if you have pictures. (Another comment on the surveys: More pictures!) If you have researched ancestors in middle or east Tennessee, please send us your articles; we are committed to publishing material from all parts of Tennessee, not just this area.

As a new editor, I felt the need to include an index of the contents of back issues of <u>Ansearchin' News</u>, by county, and hope that this has been an aid to our local and out-of-state members. In a continuing series of articles, I will list journals published in other parts of Tennessee, and hope that you will contact the editors of these journals to see if they might have information you need.

Our next issue will focus on the city of Germantown; please contact us now if you have any pictures, histories or stories we might use.

FROM THE PRESIDENT

As our moving date draws near, mid-October, I contemplate with trepidations the changes and adjustments we must make as we integrate our operations with a major public library system. How will we channel our assets, in people and money, to maximize the research capabilities of the facility and improving the skills of the researcher?

Our greatest asset, of course, is people who voluntarily share their time and talents with us.

It is such a pleasure to work with the many talented and dedicated volunteers who strive to perpetuate and enhance the very significant collection of genealogical and historical information that the Society has amassed during the last fifty-two years and to make it available to the greatest number of researchers.

I won't, in this column, list the names of the volunteers already noted on the title page (page 128) but I do want to recognize some of the accomplishments during our 10-years at Davies Plantation.

Since our librarian was forced into her job by the death of her predecessor, she has installed a user-friendly computer system to manage our collection—we have lost only one book during her tenure—and she has more than doubled the number of books in the collection to over 14,000. She and her staff have cataloged thousands of pages of family history and have created a cross referenced index of surnames. She manages all the volunteers who work the check-out desk and shelve books.

Our corresponding secretary, who does research for our clients, sometimes becomes so involved with the clients' family that it becomes an obsession to identify "the grandchild of uncle Joe's third wife's second cousin twice-removed."

We've had three magazine editors Every one of a them has been a skilled researcher, editor, and publisher. Does anyone want to guess the number of hours this person devotes to creating this outstanding genealogical magazine?

As treasurer we have had the full range of people from CPA, to retired military, to house wife. We've never had a past-due bill and only one late tax report. All of our audits have been ratified. Could we ask for more?

Our vice president, in addition to other duties, is our program director. I review the list of speakers, trainers, rein-actors, authors, hobbyist, etc., presented to our membership, with much pride in the quality of the presenters our VIPs have booked and in the support the membership and community have given our efforts.

We have had four web masters. Our web site is user-friendly and it is updated regularly. Take a look at www.tngs.org!

We have had three directors of sales. This person is responsible for the inventory control of our extensive selection of published material and for fulfilling orders. It requires knowledge of postal regulations, reproduction of materials, and the willingness to do some "grunt work."

How fortunate we are to have such a pool of talented volunteers.


As I survey mentally the great number of talented and dedicated people I have to help with "the changes and adjustments we must make," the changes and adjustments become less daunting.

McNairy County, Tennessee – Register of Deeds Vol. A Dec 1823—August 1838

McNAIRY Boundaries 1 Jan 1824-Apr 1882



McNairy County was formed 8 Oct., 1823 from Hardin County. McNairy County is bordered on the south by Alcorn County, Mississippi and in Tennessee by Hardeman, Chester and Hardin Counties.

Page 1

Made the second day of December in the year of our Lord 1823 between William L. Petty (of Henderson county, Tenn.) and James Surratt of McNairy Co., Tenn. for the sum of \$168.00. The receipt is hereby acknowledged. The land situated lying and being in the county of McNairy state of Tenn. containing 42 acres by entry No. 1267 granted to said Petty by state of Tenn. by grant No. 20127 dated the 10 Sept., 1823.

W.L. Petty (seal) Signed, sealed and delivered in the presence of: William Boyd, Jacob Oxford State of Tennessee, McNairy Co. Court of plea and quarter session August term 1824. I, Joseph W. Barnett clerk of said court do certify that the within deed of conveyance was produced in open court and duly proved the oath of William Boyd and Jacob Oxford subscribing witnesses there to and ordered to be certified for registration.



KINFOLKS FOUND IN LAUDERDALE COUNTY, TN.

- p. 404 James Hubbard, Dr. E. S. Campbell, and Rezin G. Henley, freeholders unconnected either by affinity or consanguinity with Nancy Temple, widow of Green B. Temple, dec'd, were appointed to set apart so much of the crop, stock, provision, and monies as may be necessary for the support of her and her family for one year from the decease of her husband and report in April.
- p. 410 **Isaac D. Maxwell** was appointed guardian of **Dulcinia**, **Mary, Solomon, Isaac, James, and Elvira Maxwell**, his own children and heirs at law of **Nancy Maxwell**, his deceased wife, formerly **Nancy Byler**. He entered into bond of \$400, with

John H. Maxwell and Isaac M. Steele his securities, and took the oath.

- p. 411 John H. Maxwell was appointed guardian of Abraham B., Bedford C., Elizabeth, and John Maxwell, his own children and minor heirs at law of Elvira Maxwell, his deceased wife, formerly Elvira Byler. Lee** to give new and counter security in place of the said **H.A.G. Lee** or deliver up the estate. (p. 418) **Guilford Jones** came and offered himself as security.
- p. 421 **February 7, 1842** Williamson Price has died intestate and, the court being satisfied with the claim of **James Price** to administer the estate, has issued letters of administration to him. **Archer Phillips** and **Edmund Fitzpatrick** are his securities.
- p. 422 Ransome Hawkins was appointed guardian of Catherine Hawkins, minor heir of Martha Hawkins, dec'd, formerly Martha Williams. Henry Willard and Abel H. Pope entered with him into bond as his securities.
- p. 435 **March 7, 1842** Gilbert Elam has died leaving no will and Ezekiel Farmer, a creditor, was made administrator.
- p. 461 **April 4, 1842** Ordered that **John W. Hammil** be paid \$5 for making a coffin for **Isaac Perterson.**

- p. 464 **April 5, 1842 Joshua Wright** has died intestate and with the widow having relinquished her right to the administration, the count made **G. L. Rutherford** administrator.
- p. 465 **Robert Maxwell** has died intestate. **Joel Kirby** applied for and received letters of administration.
- p 472 **May 2, 1842 Isaac [Braden],** coroner of Lauderdale county, presented two inquisitions held by him on the bodies of **Henry Kimmons** and a person unknown.
- p. 474 June 6, 1842 Armistead Wood, Samuel Lusk, and William Deason, freeholders, unconnected by affinity or consanguinity to Mary Wright, were appointed to set apart so much of the crop, stock, provisions, and monies on hand of the estate of Joshua Wright, dec'd, as may be necessary for Mary Wright, his widow, for one year from his decease.
- p. 475 Ordered that **Benjamin Nearn, Jesse Ledbetter**, and **William R. Ledbetter**, freeholders unconnected by affinity or consanguinity with **Nancy Maxwell**, a child under 15 years of age, minor heir of **Robert Maxwell**, dec'd, be appointed to set apart so much of the crop, stock, provisions, and monies on hand or due or other assets of the estate as may be necessary for her support for one year after his decease.
- p. 482 -3 July 4, 1842 I. M. Steele, G. L. Rutherford, and Jonathan L. Hearring were appointed to divide the negroes devised by the last will of Amy (or Aney) Richardson, dec'd, among Rebecca A. Lackey, (formerly Rebecca A. Richardson), Mary A. Richardson, and Virginia A. Richardson, children of S. Richardson and report to the October term of this court.
- Ordered that **Isaac Braden**, coroner, be paid \$6.50 for funeral charges incurred by him in burying **Henry Kimmons** and a person whose name is unknown.
- p. 486 The court appointed **John Thompson** guardian of **John W. Rudder**, an orphan and minor heir of **Saml. Rudder**, instead of **Moses E. Stone**, former guardian. **A. O. Thompson** and **William A. Wood** were securities on his bond.
- p. 487 **Robt. B. Blackwell**, guardian of **Harriet E., Thomas J.J.,** and **June A.W. Blackwell**, minor orphans, came into court with **Archer Phillips** and **R. H. McGaughy** as his securities.
- p. 488 The court appointed **Elizabeth Reams** guardian of **William Inman**, a minor orphan, and she entered into bond with **G. L. Rutherford** and **Nicholas Reynolds** as securities.
- **Joel W. Kerby**, administrator of **Robt. Maxwell**, dec'd, being solemnly called to come into court and give additional security in accordance with the order of this court at the last term, came and refused to give additional security. It is, therefore, ordered that he be dismissed from any further administration on said estate and it is ordered that **Samuel Hankins** be appointed administrator of the estate instead of **Joel W. Kirby**.

He entered into bond with A. H. Pope and Thomas J. Childress his securities.

- William D. Crook was appointed guardian of Napoleon, Lafayette, Mary, and Margaret Crook, minor heirs, and James B. Crook and Daniel Williams were his securities.
- p. 508 **Jemima Chism** has departed this life intestate, and **William R. Chism** was appointed administrator after entering into bond and taking the oath.

The commission appointed in July to divide the Negroes devised by the last will of **Aney Richardson**, dec'd, gave **Nat** to **Rebecca A. Lackey**; **Caroline** and her child to **Virginia A. Richardson**; and **Berry** and **Mima** to **Mary A. Richardson**.

- p. 518 **November 7, 1842 Isaac Braden**, coroner, returned an inquisition held by him over the body of **Eward Harris**.
- p. 519 The court bound **Elijah W. Robison**, a minor orphan aged 11 years on 12 March,1842, to **Hiram Meadows**, to be taught the trade and occupation of a farmer and to read and write and some good arithmetic, if he has sufficient capacity. **Meadows** is also to provide sufficient diet, lodging, washing, and apparel and other necessaries suited to an apprentice both in sickness and in health; take care of his morals and treat him with humanity and at the end of the time give him one horse, saddle, and bridle worth \$75, a good feather bed, and two good suits of clothes. **William R. Chisholm** was **Meadows** security.
- p. 525 **William Elmore** and **William Ball**, subscribing witnesses to the last will and testament of **Ann Lytle**, were sworn and said they saw her execute it and subscribed it as witnesses in her presence. The will ordered to be admitted of record.

- p. 533 **Joseph Hays** was appointed guardian to **Jesse J. Moore**, **Betsy A. Moore**, and **George W. Moore** with **Joseph Wardlaw** and **Samuel A. Thompson** his securities of \$300 bond.
- p. 535 **John W. Hamil** was paid \$5 for making a coffin to bury **Rebecca Boswell**, a pauper.
- p. 536 **James Hodges** was paid \$1.50 for hauling the coffin of **Rebecca Boswell** from Ripley to the burying ground.
- p. 542 The coroner was ordered to take possession of and sell the property of **Edward Harris** and appropriate it to the payment of his burial expenses and report his proceedings to the court.
- p. 547 **February 6, 1843** Caleb W. Anderson appeared and made oath that the testatrix [testatrix was not named BBD] signed and published the writing annexed to this commission and certificate as her last will and testament, that she was of disposing mind and memory and that he subscribed his name thereto in the presence of the testatrix at her request. It was ordered to be certified to the county court of Caroline County, Virginia, to be there recorded.
- p. 549 James H. Cleaves was appointed guardian to Alfred D. Conner, commonly called Alfred D. Moore. A. S. Durham and Joseph Hays entered as securities with him on \$500 bond.
- p. 553 It appears to the Court that **Eleanor Wood**, who obtained letters of administration upon the estate of **Sabret Wood**, dec'd, from the county court of Tipton County, has departed this life before the expiration of her administration, and **William A. Wood**, having applied for letters of administration *de bonus non*, entered into bond, and taken the oath, he is to have letters accordingly.

Genealogy Travel Kit (Reprinted from TGS web site www.tngs.org)

I came across some helpful aids while doing your family history while traveling. Here are some items to have for your genealogical travel kit.

Stationery: Notebook, pens, and files or folders in which to keep your valuable documents, photographs and local information. Documents: Copies (not originals) of vital records and other archival leads Geographic Aids: Up-to-date road maps, street guides and guidebooks. (Try to find maps of the time period in which your ancestor lived. How have the boundaries changed over time periods?) Travel Documents: Passports, visas, driver's licenses, traveler's checks, credit cards, local currency, and strong foreign currency, such as US dollars or German marks.

Insurance Policy: Check to see that all your belongings and documents are covered by your travel insurance policy and you have the original purchase receipts in the event of theft.

Camera, Camcorder, & Tape Recorder: A camera, (digital if possible,) and a good supply of film. Camera film may be hard to obtain or cost much more than you would normally pay. Check to be sure your camera is suitable for photographing original documents close up and indoors, since this is an effective way of recording documents if you are not able to obtain a copy. Try photographing documents at home to make sure your camera is up to the job. Do not rely on photographs as a means of recording information on original documents. You will still need to transcribe or abstract the relevant information.

Video camcorders and audiotape recorders are useful for interviewing contacts and preserving your own experiences in the form of a diary.

Contact Details: Names, addresses and telephone numbers of your local contacts. You should also take a supply of cards or stickers containing your own name and address. You may meet people who will not be able to find out information for you and send it to you after you return home.

Phrase Book: Take a good phrase book and bilingual dictionary to help with the language. Do not assume everyone will speak your language.

Clothing: Worn-in comfortable shoes are essential for genealogical trips, whether you're are visiting foreign cities, cemeteries, farmland, cobbled streets, rural paths, or ancient church archives, dress in comfortable clothes; check ahead to see what the weather will be on the day you plan to visit.



"Nicholas and Julia Gotten" home still stands on the southwest corner of Court and Woodlawn, in Bartlett, TN.

Nicholas Gotten (1832 – 1919) Blacksmith, Civil War Veteran, Citizen of Bartlett

-Nicholas Gotten, Jr.

My great-grandfather was Nicholas Gotten (originally spelled Goetten) who immigrated to the United States in 1854 at age 22. He was from a small town in western Germany named Spangdahlem not far from the Luxembourg border. We have been able to trace his direct line of ancestors to a Peter Goetten who was born in Dahlem, Germany, in 1733. We think that Nicholas Gotten came over to America and initially settled in Chicago, although that is not yet documented. Nicholas then moved to Memphis in 1858. Why he came to Memphis is unknown, but he probably had an acquaintance here due to the fact that this area was being rapidly settled by immigrants from Germany. Not long after coming to Memphis he moved again, this time to the Bartlett, Tenn., area. He was a blacksmith by trade and soon found work there. He is listed in the 1860 census at Raleigh, Tenn., as age 28, a blacksmith, apparently living in a boarding house with numerous others. I did find from old records at the Shelby County Library documentation that Nicholas Gotten served on a jury of inquest in 1860 regarding the death of one William Holton.

For the next several years, we have very little information. When the Civil War erupted, although he was opposed to secession, he tried to enlist but was dissuaded because his services as a blacksmith were so much in demand at home. However, when Fort Donelson fell, "...his blood boiled with the heat of war, and no longer restrainable he enlisted in the company of Captain Mays, Company C, of Forrest's regiment, as a private, the capacity of which he served until the surrender at Gainesville in 1865."

The above quotation comes from *Confederate Military History*, Vol. 8. Apparently my great-grandfather made quite a name for himself both during the war and after. I will take the liberty of again quoting directly from his biographical sketch in the above-mentioned book: "He [Nicholas Gotten] fought at Shiloh, Corinth, Britton's Lane, Iuka, Thompson's Station and numerous other engagements, everywhere making a good record. At Bolivar, Tenn., May 4, 1864, he was seriously wounded and left on the field for dead. Believing the bone of his thigh to be broken and that amputation would be necessary, he exposed himself as much as possible to the field of fire of the enemy, but though bullets fell thick, received none to prevent him from being an object of charity in this cold world the remainder of his life." [I do not understand that last sentence because he lived a long life and was definitely not an object of charity. As we shall see, he was a fully functional, active, productive citizen, husband and father.—N. G., Jr.]

"Finally, some Federal soldiers came up and learning on inquiry that he belonged to McDonald's battalion, the remnant of Forrest's old command, they took him cordially by the hand, complimenting him on his membership with that famous troop, treated him with great consideration, and carried him to a house which happened to be that of the Rev. Egbert Osborn, a Baptist minister, where he remained about two months. At the rumor that the Federals were on their way to Bolivar again, he was taken to the home of Washington Checker about four miles south of Bolivar, where he remained until he could be taken in a wagon to his regiment, then at West Point, Miss. But not being able to ride a horse and keep up with his command, he was told to go back to West Tennessee until able for duty. When within four miles of Bartlett he was overtaken and made prisoner by the Federal soldiers and taken to Irving block prison at Memphis. He was offered a parole but refused to take the oath, whereupon he was informed that he would be shot to retaliate for the Fort Pillow "massacre." He in answer told the provost marshal nothing would please him better than to be a martyr for the Southern cause,

as he was satisfied that if General Forrest and the boys of the old battalion heard of it they would never take another live Yankee to camp. This had the effect of stopping all threats of shooting, and he was sent to Vicksburg, Miss. and exchanged. From there he walked the great part of the way to the old battalion, then at Jackson, Miss., and remained with it until the surrender at Gainesville, Ala. It is to the credit of Nick Gotten that he did double duty from the time he joined the regiment until wounded at Bolivar. During that time, he shod the horses for private soldiers at any and every opportunity for the good of the Southern cause, never accepting a cent of pay. He would never shoe an officer's horse for love or money as long as there was a barefooted horse in his command, and for his refusal to do otherwise was once ordered arrested, but upon his stating that his arrest would not advance the cause as he was enlisted as a volunteer soldier and shod horses voluntarily and gratuitously, he was released. The kind treatment he received from the ladies of Bolivar and the community would be difficult to describe. He firmly believes he owes his life to the particularly kind nursing and watchfulness of Miss Medora Casey, one of Bolivar's most accomplished and charming daughters. After the surrender at Gainesville, Mr. Gotten returned to Bartlett, where he now resides, smithing, ginning cotton and grinding grists for the community. He was married January 29, 1869, to Julia S. Coleman, sister of his gallant comrade, James Coleman."

So, it is apparent that Nicholas Gotten was a brave and headstrong person who survived the war having been on the front lines of some of the bloodiest battles of the war. I have documentation that he joined the Confederate Historical Association of Memphis, and is the subject of a brief biography in the book, *Old Guard in Gray*, 1897 edition.

I have in my possession his original discharge paper from the Confederate Army dated May 11, 1865 which states, "Gainesville, AL. Nicholas Gotten Private of C Company, Forrest's Old Regiment, Tenn Cavalry C.S.A. residing in Shelby County Tenn., having been, with the approval of the higher authorities, is permitted to return to his home not to be dis...[unreadable]. I hereby certify that the ? within soldier is the true and lawful owner of one horse. Charley C. Bulah, Lt., Com Co."

Nicholas returned to Bartlett upon the end of hostilities and added to his modest real estate holdings there. He also built a blacksmith shop and cotton gin. He invented a cotton gin feeder (whatever that is) and it was patented, but was not a commercial success. He married Julia Sophia Coleman on January 26, 1869, and I have a copy of their marriage certificate. She was the daughter of Stephen Monroe Coleman and Rachel Amelia Hardy. Nicholas and Julia had three children: Peter Monroe, David Henry, and Margaret (Maggie) Amelia. My grandfather was Peter Monroe Gotten, my father was Nicholas Gotten, and I have a son, Nicholas Gotten, III, and a daughter, Elizabeth Dashiell Howard.

Nicholas Gotten and wife Julia built a two-story frame house which still stands today, located on the southwest corner or Court and Woodlawn. It is owned by the City of Bartlett and has been operated by the Bartlett Historical Society as a museum and repository of records and archives relating to the Bartlett area. It has been placed on the National Register of Historic Places. The "Gotten house" was saved from the wrecking ball by the intervention of Elva Bledsoe and other worthy citizens of the area who cherish the history of Bartlett.

Julia S. Gotten died in 1892, twenty-seven years before her husband Nicholas died. He never remarried. She was buried behind their house, but was later moved to Forest Hill Cemetery. Nicholas and daughter Maggie also are buried there.

Nicholas Gotten died in Memphis August 20, 1919 at age 86. According to his obituary and death certificate, he died of arteriosclerosis and senility.

Our family is very proud of our ancestor, Nicholas Gotten. He clearly was an exceptional individual and represented to this country European immigrant's best qualities--hard work, skill, and determination. You might say that, "he had seen it all" including the most terrible war this country has ever endured. Despite the shattered economy of the South, he was able not only to succeed but to prosper and to raise a fine family. The current descendants of Nicholas Gotten have built upon the foundations that he laid and cherish the accomplishments of our founding father in this country.





Confederate States of America Roll of Honor

The Tennessee Genealogical Society published *The Confederate States of America Roll of Honor* in 2003. It continues to be one of out best sellers.

The men listed on the roll of honor included commissioned officers recommended by a superior and privates or non-commissioned officers elected by fellow soldiers for helping achieve a signal victory.

Each company was authorized to elect one private or non-commissioned officer from its unit for the honor. The roll carries the names of almost 2,100 soldiers representing all of the Confederate states. Even so, the records naming other soldiers and other battles have apparently been lost.

An example: Only ten names from only one battle have been found recognizing the 8th Tennessee Infantry Regiment.

This unit was organized at Camp Trousdale, Sumner County, Tennessee, in May, 1861. Its members were recruited in the counties of Smith, Overton, Lincoln, Fentress, Putnam, Jackson, Moore, and Marshall. The unit arrived at Huntersville, Virginia in July, 1861, with 887 men. It participated in Lee's Cheat Mountain Campaign, then was sent to Port Royal, South Carolina. It fought at Corinth, Munfordville, and Perryville. It took part in the campaigns from Murfreesborough to Atlanta, returned to Tennessee with Hood, and saw action in North Carolina. It reported 38 casualties at Perryville, lost sixty-five percent of the 474 engaged at Murfreesboro, and took 260 into the fight at Chickamauga. During December, 1863, it totaled 233 men and 207 arms. Only a remnant surrendered on April 26, 1865. (The field officers were Colonels John H. Anderson, Alfred S. Fulton, William L. Moore, and L.W. Oglesby; Lieutenant Colonels A.G. Ewing and C.C.McKinney; and Majors W.H. Botts and William G. Burford.) (note 2)

We would expect with so many men engaged in so many battles others would have been selected. For the historian, the book includes a short history of military medals for gallantry; documents relative to the establishment of the Roll of Honor, and battle reports resulting in the award. For the genealogist, the book includes the recipients' names, military units, and some biographical information. Names are sorted alphabetically by individual and also by state and military unit.

TENNESSEANS MENTIONED IN OTHER PUBLICATIONS

HON. R.R. (**UNCLE BOB**) **WILLIAMS** was born May 1, 1839 in Henderson County, Tennessee, where he lived and grew to manhood. In 1855 he moved to Dallas, Polk County, Arkansas, where he remained for some time and married Miss **Susie Ward** on April 7, 1861, at the outbreak of the War Between the States. In 1868 he moved to Texas where he engaged in farming for four years and then opened a blacksmith shop. He always took an active interest in politics, being elected to the 27th Texas Legislature and again chosen to represent Hopkins County in the 33rd and 34th legislative sessions, where he served with honor and distinction. He entered the gubernatorial race in 1908 and almost became governor of Texas. An article about **Mr. Williams'** 96th birthday celebration was published in the *Hopkins County Echo* on May 10, 1935, and was recently reprinted in *Hopkins County Heritage*, Vol. 23, #1.

RAY COUNTY, MO. BIRTH RECORDS include the following with a Tennessee connection: a son, their sixth child, was born to Newton Campbell, age 38, born TN and his wife Mary Burk Campbell, age 36, born TN, 1 Feb 1884; their seventh child, Nancy Campbell, was born May 15, 1886. Zachariah Campbell, age 33, and his wife Sarah Branson Campbell, age 32, both born TN, became parents of their seventh child, Margaret Campbell, born 1 Dec 1884. Rebecca Covey, age 24, born TN and husband, Andrew W. Covey, age 27, born MO, fourth child, male, born Dec 5 1888; Robert Druton (Dorton?), age 24, born TN and his wife Emma, age 23, born MO, second child, female, born Sept 18 1883; Robert Lafayette Dennis, age 26, born TN and his wife Rachel, age 22, born MO, first child, a female born Sept 22 1884; Alexander Douglas, age 29, born TN, and his wife Emily S., born OH, third child, a female born Jan 10 1885; John Elliott, age 30, born TN, and his wife Nancy, age 26, fourth child, a female born Jan 10 1884; Solomon Frazier (age and name of wife not shown) both born TN, second child, a male, born Sept 9 1883; the same couple, now listed as **Solomon** and Fanny Frazier, third child, male, born Oct 30 1885. Robert Fraser, age 31 born in TN, and his wife Julia Priscilla, age 25, fifth child, Zoula Fraser, born March 4 1884; Joseph E. Turrar, age 26, born TN, and his wife Sarah E., age 22, born Ray Co. MO, fourth child, a female born Oct 5 1884. Additional birth records for this county appear in Ray County Reflections, Vol. XV, #1 and Vol. XV, #2.

FIRST SETTLERS OF FISHING RIVER IN RAY COUNTY, MISSOURI – In the year 1816, fifteen young men in their early twenties from Cocke County, TN with surnames of Clevenger, Allen, Tarwater, Wells, Blythe, and probably others, traveled by barge or pole raft from Newport almost to Kansas City. The year 1816, when this exodus took place, was called "The Year Without a Summer," or in earthy East Tennessee talk, "Eighteen Hundred and Froze to Death!" It is not known which Allens made the trip. The will of Reuben Allen (wife Elsey or Elizabeth) was probated in Ray County, MO in 1833; they were born 1770-80, according to census records, and possibly were married in TN. Their 13 children were born in Tennessee between 1794 and 1828, and several are mentioned in the *Ray County Reflections* article.

CIVIL WAR PENSION APPLICATIONS for Itawamba County, Mississippi (reprinted in *Itawamba Settlers*, vol. 26 #1) include the following:

Mrs. Collin Fry Allen, widow of Nathan Fry. He was age 24 on the 1860 federal census, living in the household of Jacob and Drucilla Fry with siblings Thomas J., age 19, James, age 17, Martha,

age 14, and **Eliza**, age 12, all born in Tennessee. **Collin** and **Nathan** were married in Lee County, MS in 1884. She later remarried, but her husband was deceased at the time she filed her pension application on 5 July, 1924.

A. L. Anderson resided in Blount County, TN when he enlisted in October of 1862. **Alvin L.** age 15, is listed on the 1860 federal census in the household of **William** and **Nancy Anderson**, along with his siblings **John R.**, age 17, **Elizabeth J.**, age 12, **Mary L.** age 10, **Candace M.**, age 7, and **Celestia**, age 1, all born in Tennessee.

Also in *Itawamba Settlers*, vol. 26, #1,the article *Itawamba County Post Offices*, 1851 contains information from the 1850 federal census on postmasters and household members born in Tennessee: Cotton Ridge: **Wm. G. Tomlinson**, age 23, farmer, living in the household of Postmaster **Edmond** and wife **Sarah Ganaway**; Fulton: Postmaster **D. N. Cayce**, age 37, merchant, \$1,000, **James M.**, age 12, **Mary Ann**, age 11, **Isabella Jane**, age 10, **T.B. Gaither**, age 27, Merchant, and **William M. Gaither**, 24, clerk, **Shadrack Cayce**, age 6, born MS. Pleasanton: **Nathaniel McLellan** (also shown as **Nathaniel B. McClellan**); Richland: Postmaster **William Priestley**'s wife, **Mary V.**, age 28. Additional members of households are also listed.

NICHOLAS HORN, according to an article in the same journal, was born about 1815 in Tennessee, and was on the Itawamba County tax lists in the late 1830's. He married **Jane Hill** there in March 1841. Born in 1824, she was the daughter of **Abel** and **Leach Hill** of Wayne County, TN., and had one full brother, **Alexander Hill**. **Nicholas** and **Jane Horn** were still alive when he applied for a Confederate pension in August, 1902. Jane stated that she had borne ten children, but records only accounted for nine. Court papers indicate they both died before 1907.

AUMAN FAMILY HISTORY is the subject of an article in the Randolph County, North Carolina Genealogical Journal, Vol. XXX, #1. Family tradition held that the Auman ancestors came from Germany to Pennsylvania in the 1700's and moved to North Carolina around 1800. Mary Cagle, the second wife of Andrew Auman, appears in the 1802 will of Henry Cagle, who leaves money to "his daughter Mary Auman." Evidence suggests that Mary migrated with her children to Blount County, TN around 1820, along with several other households of Cagles and other relatives from the Moore County, NC area. They settled in the Elijoy community located on the border of Blount and Sevier counties. She was either divorced or separated from Andrew before leaving North Carolina, or Andrew went with them to Tennessee and returned to North Carolina before 1830. Land, marriage and the 1830 census records of Blount County, TN indicate that Mary Orman (Auman) lived there with sons David (b. 1800), Henry (b. 1804) Andrew (b. 1808) and Martin (b. 1809). Several of her daughters were married there in the 1820's. By 1840, Mary and her sons were living in Clay County, Indiana, where their surname appears as Aorman in the federal census.

SEVERAL TENNESSEE LINES appear in the family chart of Bernice Lillian Phillips of Etowah County, Alabama, published in *Northeast Alabama Settlers*, Vol. 45, #1. They include **Hugh Harvey Brandon** (b. Oct. 20 1808, d. Jul 5 1892 in Dekalb County, AL), his wife **Rhonda Bohannon** (b. Nov 30 1838, d. Aug 14, 1907), **Samuel C. Arledge** (b. Nov 1856, d. 13 Mar 1906 in Marion Co., TN), his wife, **Mary E. Holloway** (b. Nov 1858, d. April 1901, Marion Co. TN) and **Addie Lee Arledge** (b. 11 April 1891, Marion Co., d. 20 Sept 1981, Calhoun Co., AL.

AHNENTAFEL CHART for **Angie Beth Merchant** of Crosby County, Texas, covering 24 generations, is printed in *The Treeshaker*, Vol. 44, #1, a publication of the Permian Basin Genealogical Society, Inc. of Odessa, Texas. The chart includes several with a Tennessee connection: **William Alexander Shipley** (b. 24 Dec., 1851 in TN, d. 1 Sept., 1926 in Floyd County, TX), who married

Angeline Stanfield 5 Feb 1870, in TN. Angeline (b. 5 Aug., 1853 in TN, d. 4 Feb., 1944 in Lorenzo, Crosby Co. TX); Alexander Shipley (b. 10 Dec., 1823 in TN, d. 20 Jul., 1906 in Bradley Co. TX), who married Naomi Gibson 3 Sept., 1844 in Bradley Co. TN. She was born about 1826, in McMinn Co., TN and died in Bradley Co. TN; William Auston Stanfield, (b. 1831, died 23 Dec., 1897 in Consauga, Polk Co. TN); Mary Eliza Minnis (b. 1837 in TN, d. 1867, in Bradley Co. TN) Aquella Shipley (b. ca. 1795 in TN, d. 1846-50 in Mc Minn or Meigs Co. TN). He married Mahala Elizabeth (last name not shown), b. 28 Mar., 1805 in Meigs Co., TN and died 11 Jan., 1877 in Garland, Dallas Co. TX; William Gibson (b. 1788, d. 2 May, 1828, in TN) married Rebecca Adams (b. 31 Dec., 1793, d. 20 April ,1852, in Bradley Co. TN; Robert Minnis (b. 8 Feb., 1796, in TN, died in Blount Co, TN) married Margaret G. Steele (b. 1804, in Maury Co. TN, d. 1850-60); John McMinnis (b.21 Mar 1750 in Down, Ireland, d. 29 Jun 1838 in Blount Co. TN; Mary McChesney, (b. 1776, Augusta, VA, d. before May, 1844, in Monroe Co, TN.) She married William Steele 2 January, 1794, in Augusta, VA.

MATLOCK FAMILY of Crawford and Phelps counties appears in *Missouri State Genealogical Association Journal*, Vol. XXVI, #2. **Isham Esau Matlock**, son of **Zachariah Matlock** and **Eady (Edith)**, who was a soldier in the War of 1812, was born 1782, in Halifax Co., Virginia and died 1874, in Phelps County, Missouri. He married ca. 1808, in Washington Co., TN **Nancy Ellen Haile**, b. ca. 1787, in Baltimore, daughter or **Meshack Haile** and **Mary Carl Buckingham**. **Isham** and **Nancy**'s oldest son, **John Matlock** (b. 31 Jan., 1809, Washington Co. TN – d. 2 Nov., 1899) married on 12 April, 1827, **Melinda Ellis** in Jonesboro, TN. She was born 17 Ma.,r 1810, Washington Co. and died 27 Dec., 1898, Phelps Co., MO. They were the parents of twelve children: **Henry Beasley, Harvey, Elizabeth, William, Mauree, Sara Jane, John, Ellen, Melinda, Lusinda, Endemile, and Jerome Matlock**.

ANCESTORS OF DONA BELLE COLLINS (13 July, 1876, Robinson, AR – 22 March, 1924, Hico Township, Benton Co., AR) is published in *The Backtracker*, Vol. 35, #2 by Northwest Arkansas Genealogical Society. **Dona** was the daughter of **Jesse William Collins** (b. Dec. 5, 1853, AR – d. Sept. 10, 1919, Yell Township, Benton Co. AR) and **Mary Elizabeth Sanderson** (born June, 1857, TN) who were married Sept. 23, 1875. in Washington Co., Arkansas. **Jesse**'s parents were **Jesse Collins** (born about 1827, Bedford Co. TN) and **Mary** or **Sarah Ward** (born Sept. 15, 1829. in TN or MS). Additional information on this family can be found in the article.

DON J. BENTON ANCESTOR CHART appears in *Yellowed Pages*, Vol. XXXV, #3 and #4, published by Southeast Texas Genealogical and Historical Society. The following were born in Tennessee: **W.J. Stewart** (b. May 29, 1852, d. April 8, 1932 in Cleburne, TX; **Peter Stout Benton** (b. May 11, 1808, d. April 23, 1894) who married June 25, 1829, in Jefferson Co. TN **Martha Wilhite** (b. Oct. 15, 1808, d. Jan 3, 1884, Johnson Co. TX.)

Getting Started Online - - Family Search

Genealogy research is one of those hobbies that once started is difficult to give up. Once the bug bites, everyone out there is a potential relative – from the neighbor across the street to the kid who bags your groceries. I'm sure someone somewhere has developed a twelve-step program for this addictive behavior, but I have yet to find one.

For those of us, however, who are still in denial, the Internet can provide a quick and easy way to do some of our research from the comfort of home. The Internet has a vast expanse of information out there [both accurate and inaccurate – ed.] Families have their own websites for researchers and various companies have cashed in on the family tree hunt. Without a little guidance, though, the Internet can become a scary place.

A good place to start would be www.familysearch.org. This website is sponsored by the Church of Jesus Christ of Latter Day Saints and houses the world's largest family tree library in Salt Lake City, Utah. The Family Search website is a great place to get started for those new to family tree research on the Internet.

From their home page, you can click on Search for Ancestors and it will take you to another web page where you can enter the first and last name of the person you are looking for. Before you click Search, take a look at some of the other search options. You can narrow down your search considerably by specifying what event you are looking for, whether it's a birth, marriage, or death. Also, you can specify a year or a range of years, and put in what country and/or state you're looking for. All of these options will help clear out the people you're not looking for and zero in on the ones you *are* looking for.

Please keep in mind that the results you get come from records that have been submitted to them over the past 25+ years, which have not been verified by the Family Search website. However, they will provide you with a good start and hopefully hook you up with the relative who submitted the information.

After you enter your ancestor's name and narrow down your options, click Search and the

next screen will give you that person's record if it is in the database. Next to Submitter, about halfway down the page, you can click on Details and that will provide you with the name of the person who submitted the information.

If you need some help in getting started with Family Search, come to the Tennessee Genealogical Society library and find someone to help you use our recent sets of CD's from Family Search. You will find the Family Search 1880 United States Census and National Index on 35 compact discs, the Family Search Pedigree Resource File (also available online) and the Family Search British Isles Vital Records Index (England, Ireland, Scotland, and Wales), which contains (some) birth, marriage and death records from the period 1530 to 1906, indexed. When you get the hang of it, home research will be much easier!

There are also two Family History Centers located in the Memphis area, and all are welcome to use their resources. One is located at 4195 Kirby-Whitten Rd., near the Mormon temple. Call (901) 388-9974 to find out their current hours; in the spring, volunteers staffed the library on Tuesdays and Thursdays from 9:30 a.m. till 4:00 p.m. and on Wednesdays and Saturdays from 6:30 to 9:00 p.m. [From personal experience in Memphis, some volunteers are more helpful than others. The other Family History Center, at 8150 Walnut Grove Rd. (901-754-2545) is probably open on Monday, Wednesday and Saturday mornings; call to check their hours, and also to find out if there is any need to reserve a computer for a particular time. There are Family History Centers in every state and in some foreign countries; a directory of locations is available on Cyndi's List.

A book can be written on various genealogy websites, but hopefully this will get you started. As I do my own research I hope to find new websites to share with you. Happy Hunting!

JAMESTOWNE ANCESTORS 1607-1699: Commemoration of the 400th Anniversary of the Landing at James Towne by Virginia Lee Hutcheson Davis. 108 pages, clothbound, \$20. Genealogical Publishing Co., Inc., 2006.

The Virginia Company of London was formed and chartered to settle colonists in North America. Under this charter a fleet of three ships sailed from England on 20 Deceember, 1606 and reached the Virginia coast at Cape Henry. Sailing up the James River they arrived at Jamestown Island. Maps and illustrations from archaeological work are included to show where some colonists lived and how life evolved in this settlement. Land owners and members of government who can be documented as living on the Island from 1607 to 1699 are listed. Names of individuals designated as "Ancient Planters" are given, as well as 82 pages of Jamestown Ancestors, time period and their role, and origins or country represented. There are notes on recommended sources for further research on these colonists and their places of origin, and a supplementary list of other settlements in Virginia before 1624. This book will be a valuable resource for those whose ancestry can be traced to this area.

THE ENGLISH ANCESTRY AND HOMES OF THE PILGRIM FATHERS Who Came to Plymouth on the "Mayflower" in 1620, the "Fortune" in 1621, and the "Anne" and the "Little James" in 1623 by Charles Edward Banks. 187 pages, clothbound, indexed, \$20.00. Published 1929, reprinted 2006 with additions and corrections by Genealogical Publishing Co.

Historical evidence of the origins of the Plymouth Pilgrims is presented in this work, with explanations of church memberships and localities of their former homes in England. New facts are added to the historical records of the Mayflower which show that the ship was still in existence at least until 1636. Passengers of each ship are listed separately and alphabetically. Information with supporting documentary references shows all new or known facts concerning each Pilgrim, including his or her

place of residence in England as well as parentage and ancestry. This book is of interest both for the history of the four ships and the stories of their passengers.

THE GREAT WAR: A Guide to The Service Records of All the World's Fighting Men and Volunteers, by Christina K. Schaefer. 204 pp., illustrated and indexed, cloth cover, \$22.50. Published 1998, reprinted 2006 by Genealogical Publishing Co.

Few if any, veterans of the "War to End All Wars" or "The Great War" (WWI) are alive today to tell stories of their memories of this war. Research tips in the book explain how to reconstruct and search the records of this era, and how to find materials available from each country. This one-of-a-kind book provides a time line of major events of the First World War, starting in 1914 and ending in 1923 with the evacuation of Allied troops from Constantinople. The book begins with a background of the organization of the military. The second part focuses on participants in each country's armed forces. Many records have been filmed by the LDS Church and are identified by roll number. There are sections dealing with the aftermath of the war, casualties, and POW records, and an appendix that gives online research sources. Researchers of this era of our world and genealogical history will find information and resources in this book invaluable.

SUFFOLK COUNTY WILLS, Abstracts of the earliest wills on record in the county of Suffolk, Massachusetts. Indexed by Judith McGhan. Published 1874, reprinted 2005 by the Clearfield Co.). Paperback, 432 pages, \$38.50.

This book covers the first 30 years of Suffolk County, from about 1640 to 1670, and includes over 12,000 names of family members listed in these early wills. Originally published in *The New England Historical and Genealogical Register*, this book brings these estate records conveniently together in one book. In addition, the index makes it much easier to find an ancestor's name.

Some of the original records in this book are no longer available.

EARLY WESTERN AUGUSTA PIONEERS

by George Washington Clee. Published 1957, reprinted 2005 by the Clearfield Co. VA.) Paperback, 492 pages, \$40.

When originally established in 1745, Augusta County, Virginia covered the area from the Alleghenies to the Mississippi and from northern Tennessee to the Great Lakes. The area was settled primarily by Scotch-Irish and German immigrants and a few English. In addition to the family histories of these people, there is a short history of why they came to this area. The book is divided into 20 parts, each the genealogy of a family. Surnames covered are CLEEK, GWIN, LIGHTNER, WARWICK, BRATTON, CAMPBELL, CARLILE, CRAIG, CRAWFORD, DYER, GAY, GIVENS, GRAHAM, HARPER, HENDERSON, HULL, KEISTER, LOCKRIDGE, MCFARLAND and MOORE, and allied families are also mentioned.

HISTORY OF SURRY COUNTY, NORTH CAROLINA by J.G. Hollinsworth. Published 1935, reprinted 2001 with new index by Southern Historical Press. Hard cover, 288 pages, NC #58, \$35.)

Surry County, North Carolina was established in 1771 from Rowan County. At that time it was bordered by Iredell, Rowan, Stokes and Wilkes counties, N.C. and by Henry County, Virginia to the north. This history covers primarily the northwest portion of Surry County, but also includes events in surrounding areas. Beginning with information about the Indians in the area, the book proceeds with the coming of the white explorers and frontiersmen, covering the politics, trade, agriculture, education, newspapers and religions of the area. Particularly helpful to the genealogist are the lists of the men of Surry County who fought in various wars, from the local militia and Revolutionary War soldiers to World War I.

GENERAL ALPHABETICAL INDEX TO TOWNLANDS AND TOWNS, PARISHES AND BARONIES OF IRELAND,

published in 1861 and based on the 1851 census of Ireland; reprinted 2006 by Genealogical Publishing Co. Inc. with permission of the Controller, Stationery Office, Dublin. 968 pages, clothbound, \$60.

In addition to listing townlands, towns, parishes and baronies, this book shows the number of the sheet of the ordnance survey maps in which they appear; the areas of the townlands, parishes and baronies; the county, barony, parish and poor law union in which the townlands are located. Also included are the volume and page of the 1851 townland census with the population and number of houses in 1841 and 1851 and the poor law valuation in 1851. If the townland had more than one name, such as Ballydally/Derrynagall in the parish of Kilbride, barony of Ballycowan, King's County, both names are listed. In the absence of census records, this book is an essential reference for anyone serious about doing genealogy research on Irish families.

A HISTORY OF MIDDLE NEW RIVER **SETTLEMENTS and Contiguous Territory** by David E. Johnston. Published 1906 and reprinted 2006 by the Clearfield Co. Paper

cover, illustrated and indexed, 531 pages, #9738, \$39.50.

When the author started to write a history of Mercer County, Virginia, he soon found that the settlement of the area and incidents connected with the lives of the people there are interwoven with those of others who settled along the waters of the Clinch, Sandy, Guyandotte, Coal and other rivers and streams. This history spans the years from 1654 to 1905 and covers mostly settlement along the New River in Mercer and Monroe counties in modern West Virginia and Tazewell and Giles Counties in Virginia. Genealogists will be interested in the family histories of those with the following surnames: BAILEY, BANE, BELCHER, BLACK, BARNES, BOWENS,

BURKE, CALFEE, CAPERTON, CHAPMAN, CHRISTIAN, CECIL, CLAY, CLOYD, DAVIDSON, EMMONS, FRENCH, GILLESPIE, HALE, HARE, HOGE, HOWE, JOHNSTON, MCDONALD, PACK, PECK, PEARIS, PETERS, SHANNON, SMITH, SNIDOW, STRALEY and WHITTEN. Also listed are judges, chancellors, justices of the peace, sheriffs, state senators and representatives, attorneys and soldiers in various military units.

COLUMBIANA COUNTY OHIO MARRIAGES 1800-1870...and other evidence of marriages, by Carol Willsey Bell, C.G. 1990, The Clearfield Co., 355 pages, indexed, paper cover, 8 ½ x 11 format, #9885, \$39.95.

Columbiana County, formed in 1803, was the parent county in whole or in part of Stark, Wayne, Carroll and Mahoning Counties in Ohio, and is adjacent to Beaver and Hancock Counties in Pennsylvania. To make this book the most comprehensive source of information for the period covered, the author has gone to great lengths to find marriage records of all kinds. For example, records from the six Quaker meetings in Columbiana County, which are not listed in county records, show that at least two ministers did not send evidence of marriages they performed to be recorded. At this time, Ohio charged a marriage license fee, so many couples went across the state line to marry at no charge in Pennsylvania. Other sources used as evidence of marriages were newspapers, wills and probate records, deeds, and birth and death records. The marriage records in this book are arranged alphabetically by the surname of the groom, with an additional index listing the names of brides and other persons named in the abstracts.

PASSPORTS OF SOUTHEASTERN PIONEERS 1770 - 1823: Indian, Spanish and other Land Passports for Tennessee, Kentucky, Georgia, Mississippi, Virginia, North and South Carolina by Dorothy Williams Potter. Published 1982 and reprinted 2005 by the Clearfield Co., 449 pages, illustrated and indexed, \$38.50.

At this time southern states east of the Mississippi were under Spanish or Indian jurisdiction, and passports were required to enter these territories in the Mississippi Valley. This book is compiled from records in state archives, the War Department, and Spanish and British documents from West Florida. Included in the material from the War Department are passports from Creek, Cherokee, Chickasaw and Choctaw agencies. Records from Kentucky, Tennessee and Georgia, as well as from North Carolina and Pennsylvania, are from state archives. One section covers travel and trade on the Mississippi River under the Spanish. Passport information may include individuals, if traveling with wife and children, (and possibly relationship to others in the party), state where presently living, and destination. There are over 50 pages of additional notes and references. This book should be a valuable resource for many.

BLACKS FOUND IN THE DEEDS OF LAURENS AND NEWBERRY COUNTIES, S.C. 1785 to 1827 – from Laurens County, SC Deed Books A-L (1785 – 1827) and Newberry County, SC Deed Books A-G (1785 – 1805) Abstracted by Margaret Peckham Motes. Published 2006 by the Clearfield Co., 204 pages, indexed, paperbound. \$24.50.

Laurens and Newberry counties were formed in 1785 from part of Ninety-Six District. Included in this volume, 26 types of deeds are indexed which contain names of blacks and mulattoes in bills of sale, marriage contracts, estate settlements, emancipations and mortgages. The date of the deed, resident counties of parties to the transaction, names of African-Americans and identifying comments, are listed, as well as the surnames of some free blacks and their relationship to some white families. The names of several thousand men and women appear in this book.

A DICTIONARY OF SCOTTISH EMIGRANTS TO CANADA BEFORE CONFEDERATION, Volume 4, by Donald Whyte. Published by Ontario Genealogical Society, 2005.

The fourth and final volume in this series documents thousands of Scots who came to Canada before 1867. Included are fur traders, explorers, bankers, railway builders, politicians, farmers, teachers and journalists. Donald Whyte consulted numerous sources, printed and manuscript, and gathered much information by extensive correspondence that would not otherwise have been saved for posterity. There is a bibliography of genealogical periodicals and addenda with additional information about immigrants listed in the first three volumes. A must for anyone searching for Scottish ancestors in Canada.

INDEX TO LAND SETTLEMENT IN THUNDER BAY DISTRICT by Art Gunnell and Susan Smart. Published by Ontario Genealogical Society, 2005, 250 pages with maps, \$26.95. www.ogs.on.ca

Extensive land settlement in Thunder Bay District started when the Ontario government passed the Free Grant and Homesteads Act in 1868. The Department of Lands and Forests, now the Ministry of Natural Resources, kept records of the original transfer of Crown Lands to private ownership. Information in this book is taken from those records as well as from mining patents issued by the Department of Mines and land grants provided by the government as a reward for military service. This index covers 40 townships and gives the name of the first grantee or mining claim owner, the exact location of the land and the date of the patent. More than 8,425 names are listed in transactions ranging from the 1870's to about 1950.

IRELAND AND IRISH EMIGRATION TO THE NEW WORLD, FROM 1815 TO THE FAMINE by William Forbes Adams, PhD. 444 pages, indexed, paperbound. Published 1932 and reprinted 2006 by the Clearfield Co. \$37.50.

Although Ireland was little affected during the Napoleonic Wars, peace-time disorganization, the scourges of disease, famine, and civil disorder descended upon the land and during the next half century, three million of its citizens left the country. From 1815 to the potato famine of 1845-46, over one million people left Ireland for America. There were social, economic, and political reasons for the migration, including the ratio of population to useable land. Some topics covered in the book are: Ireland in 1815, the migrant trade, the rise of large scale emigration, and government policy affecting assisted and unassisted emigration. There is also a section giving Statistics of Irish Emigration, 1815-1845. The book is well-written and researched, and will lead to a better understanding of the reasons some of our Irish ancestors came to the New World.

ENGLISH DUPLICATES OF LOST VIR-GINIA RECORDS by Louis des Cognets, Jr. Published 1958 and reprinted 2006 by the Clearfield Co. 380 pages, indexed, paperbound, with text copies of original documents. \$36.00

If you believe you had ancestors in Virginia during the Colonial years of 1669-1735 and think you have searched all of the old colonial records, you may find new information in this book, which has been reprinted twice. The table of contents begins with Civil and Military Officers, Delinquent Estates, and Grievances after Bacon's Rebellion, only three of the twentyeight sources of records. You may find that an ancestor was a French refugee or arrived on a ship from England. Included are transcriptions of original documents, land patents, jury records, and Indian claims. All of the documents are clearly dated and give many details about the people listed, including their occupation and names of family members. A surname index is provided. As stated by Milton Rubincam of the National Genealogical Society Quarterly, "No student of Colonial Virginia history, biography and genealogy can afford to be without this source book

This compact disc includes the names of over 353,000 individuals from such sources of information (in the Colonial period in Virginia) as newspaper abstracts, military and local court records, tax lists, and marriage records. Much of this valuable data was compiled before Virginia kept centralized records (for example, Virginia tax payers, 1782-1787) and before the first U.S. census was taken. There also are biographical sketches and local histories.

Tennessee Ancestry Certificate Program

The Tennessee Genealogical Society sponsors this program to recognize and honor the early settlers who helped shape the great state of Tennessee. Persons wishing to place their ancestors in this roll of honor are invited to submit an application with supporting documents or other evidence that proves their prime ancestor lived in Tennessee or the area that became Tennessee before 1880. Family charts or computer printouts are not considered sufficient proof.

Attractive hand-lettered certificates suitable for framing are issued each person whose application meets program qualifications. The certificates are inscribed with the prime ancestor's name, when and where he or she settled in Tennessee, and the applicant's name.

Contributions

Every member of TGS is welcome to submit unpublished material of genealogical value. Material from all Tennessee counties, pre-1900, is our priority. Information should include subject's surname, given name, middle name, dates of birth, marriage, death, parents, spouse, children, origin, state and county. Please include name, address and e-mail address on the back of the card.

able for framing are issued to each person whose application meets program qualifications. Certificates are inscribed with the prime ancestor's name, date and place of settlement in Tennessee along with the applicant's name. NOTE: TGS has published two volumes of *Tennessee Settlers and Their Descendants* compiled from information contained in these applications, and will publish a third volume when adequate numbers of additional applications are received.
